


## Increasing Target Population Adoptions



### **Child-Focused Recruitment**

- Carry smaller caseloads (15 20)
- Build meaningful relationships with children
- Research all aspects of the child's journey in care / case file review
- Develop a dynamic recruitment plan
- Conduct a diligent search within child's network, including relatives
- Determine adoption readiness
- Assure adoption preparation





## **National Evaluation**

"Wendy's Wonderful Kids substantially and significantly increases adoptions from foster care."

Child Trends\*

- Children served by WWK are more than
   1.5 times more likely to be adopted
- Older children are up to 3 times more likely to get adopted
- Children with specific mental health needs are more than 3 times more likely to get adopted
- Older youth opposed to adoption were more likely to consider adoption when working with a WWK recruiter


### AS OF 12/31/17

- 338 recruiters supported
- 17,427 children served
- 11,391 children matched
- 696 in pre-adopt placement
- 6,928 adoptions (including 429 guardianships)

In a non-family placement: 34%


• Has TPR: 84%

## Nationwide Impact by 2028

50 states and D.C. scaled; continued provincial growth

**60,000** children adopted, **70% more** than would otherwise have been adopted

\$1.5-2 billion in savings to child welfare systems

Significant long-term financial & social benefits from reduced homelessness, unemployment, incarceration, early parenting and substance abuse



### **2017 ADOPTION ATTITUDES SURVEY**




- Commissioned by Dave Thomas Foundation for Adoption
- 2002 (phone), 2007 (online/benchmark year), 2012, 2017 (+foster care)
- 2017: 1,448 participants (18 years+, U.S. resident) with oversampling of Hispanic, African American participants
- Data weighted to be representative of the U.S. adult population by gender, region, race/ethnicity, age, income and education; data are also weighted to reflect respondents' propensity to be online
- Drives DTFA messaging, communications, PSAs, etc.



## harris poll Foster care adoption

- 79% of Americans who have considered adopting, but have never adopted (25%) have considered foster care adoption (+7%)
- 82% of those Americans are serious about it (+6%)
- 58% believe all children are adoptable (+7%)
- 80% know children are in care because they have been harmed, yet 46% believe children in FC are juvenile delinguents (men and age 65+)
- Those interested in general or foster care adoption continue to show a strong preference for younger children


### Age preference when considering adopting





# harris poll Foster care

- 81% of Americans say they feel extremely favorable/ very favorable/favorable towards foster care parents
- 28% have considered foster parenting
- Over 7 in 10 say they are considering becoming a foster parent to help a child in need, while half are aware of the need for foster parents
- 51% say they are not at all familiar with what foster parents do to care for children who have been abused or neglected; 22% are somewhat familiar
